3. Public Comment Period – No public comment.

APPOINTMENT

4. PA Department of Aging – Nathan Lampenfeld, TITLE and Jessica Pierce, Executive Assistant were present for today's meeting via phone to present the draft 10-year strategic plan, Aging Our Way PA, A Plan for Lifelong Independence; with the goal to coordinate infrastructure and services for older adults. The strategic tactics for the Plan were developed from the input from older adults (60+), family and caregivers of older adults and from the collaborated

efforts of 'sister' agencies, the Governor's office and community partners in each county; the strategic tactics include: unlocking access by eliminating barriers; aging in the community in terms of maintaining secure housing; gateways to independence through safe and unhindered mobility; caregiver supports such as support, training, respite and navigation tools; education and navigation to streamline resolution of complex problems.

The input was obtained via direct engagement sessions with the Area Agencies On Aging from each county, as well as a phone survey and an on-line version. The survey questions were framed around eight (8) domains of livability:

•Housing, •Outdoor Spaces and Buildings, •Transportation, •Civic Participation and Employment,

•Communication and Information, •Respect and Social Inclusion, •Social Participation, and •Health Services and

Community Supports. Survey results indicate significant concern with Housing and Transportation; the public comment topics of concern for older adults included: exclusion in terms of daily living centers, LIFE programming and incarceration, behavioral health and suicide prevention, next steps to implement the plan, language changes and tactic suggestions, and language support/concern in terms of legal immigrants and refugees.

The public comment period ended March 2024; the final draft of the Plan to be published in May, which is Older Americans Month. The publication of the Plan will be available to view on the Aging Our Way, PA website.

A Q&A period focused on this plan assisting smaller communities to access grant funds for smaller projects for safe walkability purposes like sidewalk repairs, parking and lighting enhancements; this is accomplished by focusing on several small communities that group their microprojects together to raise cost to meet the threshold requirement. Comments were also heard regarding sidewalk maintenance in terms of homeowner/landlord responsibility.

Ms. Pierce explained that she is currently working on the state-level, age-friendly designation application, which does not have eligibility requirements. This initiative is coordinated through AARP. Although there are no eligibility requirements, there are steps to be completed in the designation process; one of the steps is to compile an inventory of what programs and infrastructure currently exist. This designation provides toolkits, reassurances and shared grant opportunities.

Mr. McFarland stated the City has interest in several programs mentioned regarding housing codes but not for discussion at this time. Ms. Pierce noted that in addition to building new durable housing resources, the EDUs and ECHOs, the SHARE program also provides housing resources.

Mr. Lampenfeld and Ms. Pierce thanked the Planning Board and welcomed any further questions/comments and that they can be reached via phone email.

DEVELOPMENT APPLICATIONS

<u>Kulp Family Farm LLC</u> – located along Cove Mountain Road in North Woodbury Township. The development plan proposes construction of a 10,800 sf hay and equipment storage building and two 17,920 sf calf barns; along with associated gravel driveways and a concrete tank for stormwater management. Consultation with PennDOT BOA and possibly the FAA as this site is located within a Federal Aviation Airport Hazard Area; if determined to be a risk to air traffic, the developer must follow Penn DOT BOA and/or FAA restriction and mitigation requirements.

The presence of the 100-year floodplain exists, however the proposed structures would not be located within the hazard area. The site is located within the Frankstown Branch of the Juniata River Watershed; due to the proposed stormwater management controls, the post-construction stormwater runoff rates are calculated to be lower than pre-construction, which should help mitigate negative impacts on the watershed. Board member comment was heard regarding the 100-year flood plain in terms of drainage in front of the barns.

In summary, this proposal is consistent with countywide planning efforts as presented in the *Alleghenies Ahead* Regional Comprehensive Plan, adopted July 31, 2018, which includes comprehensive planning for Blair County.

6. <u>Pleasant View Farms</u> – located at 261 Pleasant View Farms Road in the Townships of Taylor and North Woodbury. The development plan submitted proposes construction of a 88,200 sf freestall barn, associated gravel driveways and pads, infiltration basins and grassy areas. Because this development is currently an operational farm, the additional vehicle traffic is not expected to create a negative impact on the local transportation system.

The site contains the presence of prime ag soils and is completely within an Agricultural Security Area; however, this is not a concern as the proposed structures would not be located in the flood hazard areas and because the structures are for agricultural-related business, are compatible with the land use for the Agricultural Security Areas. Consultation with PennDOT BOA and possibly the FAA as this site is located within a Federal Aviation Airport Hazard Area; if determined to be a risk to air traffic, the developer must follow Penn DOT BOA and/or FAA restriction and mitigation requirements. The site is located within the Frankstown Branch of the Juniata River Watershed; due to the proposed stormwater management controls, the post-construction stormwater runoff rates are calculated to be lower than pre-construction, which should help mitigate negative impacts on the watershed. Board member comment was heard regarding the 100-year flood plain in terms of drainage in front of the barns.

Dialogue continued with regard to the aviation regulations.

In summary, this proposal is consistent with countywide planning efforts as presented in the *Alleghenies Ahead* Regional Comprehensive Plan, adopted July 31, 2018, which includes comprehensive planning for Blair County.
